#### **Special Instructions:**

- 1. Tri-Services: Army Educational Institutions and Institutes: Here, it is stated that all Cat 'A' and Cat 'B' institutions coming under the ambit of Govt of India O M N. PC-1(16)/2017/D(Pay/Services)/Pt II dated 28/11/2019 will warrant the expost Facto approval of MG/JS, Dept of Military Affairs, South Block, New Delhi to accept and pass for payment in audit of all time bar claims of Army Officers except the cases related to NDC, New Delhi which will need the exclusive approval of Jt Secretary (Trg) and CEO, South Block, New Delhi for it's admittance for payment if it is time barred and beyond 2 months in each case.
- Medical Services: DGAMFS Full Powers.
- NCC: DG NCC Full Powers.
- 4. Misc: for COVID19 related cases: Army Cdr, ARTRAC approval.
- 5. ARTRAC: All other cases except for Tri Services educational institute and institutions.

  Note: Powers exercised by Head of Office (HOO) / Controlling Officer (CO) will be on the basis of delegation of power by the Head of the Department (HoD) and the delegation should be conveyed to the audit authorities insisting before hand with their seal and signature.
- 6. Since the matter has already been referred to CGDA, HQrs Office, New Delhi, the competent authority i.e. PCDA, has directed to follow the above mentioned guidelines for regulating TA/DA strictly as an interim arrangement as per the rules, till receipt of further directives/guidelines from the CGDA, HQrs Office, New Delhi. These may please be treated as an interim order and arrangement to avoid the subjectivity, ambiguity and standardized of the successful culmination, finalization of these TA/DA claims. It will reduce large grievances of Army Officers.

It may please be noted that any deviation or divergence in audit while regulating such TA/DA and LTC Time barred claims away from the prescribed method / procedure as devised in the Tech Circulars ibid will be viewed seriously by the competent Authority i.e. PCDA (O), Pune and appropriate disciplinary action will be initiated for the default/ lapse and non compliance. The contents of this circular may please be got noted by all concerned for ensuring their immediate strict compliance and action.
